

# Rental Vehicle Terms & Conditions

By renting or using our courtesy vehicle, you (“Renter”) agree to the following terms and conditions:

## 1. Eligibility & Authorization

- Renter must be **at least 25 years of age** and possess a **valid driver’s license**.
- Renter must provide **proof of insurance** prior to vehicle release.
- Only the **approved renter** may operate the vehicle unless prior written approval is granted.
- The vehicle may not be used for racing, towing, ride-share services, delivery services, or illegal activities.

## 2. Rental Period

- The rental period begins at vehicle pickup and ends at vehicle return.
- Rental is intended **only for the duration of your scheduled service** unless otherwise agreed in writing.
- Late returns may result in **additional daily charges**.

## 3. Fees & Charges

- Rental rates are charged on a **per-day or half-day basis**.
- A **security deposit** may be required prior to release.
- Renter is responsible for:
  - Excessive interior or exterior cleaning
  - Charging fees if returned with significantly reduced battery level
  - Traffic tickets, parking violations, tolls, or fines incurred during the rental period

## 4. Vehicle Condition

- The vehicle will be provided **clean and in good operating condition**.
- Renter agrees to return the vehicle in **similar condition**, normal wear and tear excepted.
- **No smoking, vaping, pets, or food abuse** permitted inside the vehicle.

## 5. Charging & Battery Use

- Vehicle is provided with a reasonable charge level.
- Renter agrees to operate and charge the vehicle responsibly.
- Damage caused by improper charging or misuse of charging equipment is the responsibility of the Renter.

## 6. Accidents, Damage & Liability

- Renter is fully responsible for **any damage, loss, or theft** occurring during the rental period, regardless of fault.
- Any accident, damage, or mechanical issue must be **reported immediately**.
- Renter authorizes Magnicolor to charge repair costs, insurance deductibles, or loss-of-use fees if applicable.
- Personal belongings left in the vehicle are not the responsibility of Magnicolor.

## 7. Insurance

- Renter's personal insurance is **primary coverage** for the rental period.
- **Magnicolor** does **not provide insurance coverage** for renters.
- Proof of insurance must be provided before release of the vehicle.

## 8. Prohibited Use

The vehicle may not be used for:

- Off-road driving
- Towing or hauling
- Ride-sharing or commercial delivery
- Racing, reckless driving, or illegal activities
- Allowing unauthorized drivers

## **9. Right to Refuse or Terminate Rental**

We reserve the right to:

- Refuse rental at our discretion
- Terminate the rental agreement if terms are violated
- Recover the vehicle immediately if misuse is suspected

## **10. Acknowledgment & Acceptance**

By accepting the rental vehicle, the Renter acknowledges that they have read, understood, and agreed to all terms and conditions listed above.
